<u>ADDENDUM NUMBER 2</u> - This Addendum is issued to make the clarifications in response to questions received from potential bidders through July 3, 2024.

1.0 BID DOCUMENT CHANGES/ADDITIONS:

1.1 **Exhibit B1 – Court Specifications** has been added (6pgs).

1.2 **IMPORTANT**: **BID OPENING DATE has been postponed to Wednesday, AUGUST 7th.** Time of day and location remain the same.

2.0 QUESTIONS and ANSWERS:

- Q: Can someone still submit the bid for this project if they miss the Pre-Bid Meeting? No. Any bid received from a company not attending the mandatory pre-bid meeting, would be disqualified as non-responsive.
- Q2.1 SPORTS FIELDS I see several sports fields but don't see any specifications for those. Are they existing fields? Or will these be constructed at a later time?

 The proposed sports fields shown in the plans are to be final graded and sodded as shown on Sheets C07 and C08. The City of Fort Walton Beach will stripe fields and provide field equipment.
- Q2.2 Exhibit A <u>Drawing C05</u>; SPORTS FIELDS Please provide an equipment schedule for all the sports fields/courts.
 - Pickleball Courts will include nets, net posts, see specifications for details.
 - Basketball Courts will include basketball goal, backboard and post, coordinate selection with City of Fort Walton Beach.
- Q2.3 Exhibit A <u>Drawing C04</u>; SPORTS FIELDS Are we to include sports field/court line striping in our bid? If so then please specify striping products/methods. Please include courts striping, see specification attached. SEE EXHIBIT B1.
- Q2.4 <u>Exhibit A Civil Plans Sheet C05</u>; PICKLEBALL CTS notes that eight of the pickleball courts are covered. However, there are no drawings showing the structure that will cover those courts. Please provide drawings.

Q2.6 <u>Exhibit E – Pricing page; Line 30</u> – PICKLEBALL CTS - Can you provide any information on the Class 3 material that we need for to Unit price?

According to Florida Administrative Code, Section 62-701.200 Definitions:

(14) "Class III waste" means yard trash, construction and demolition debris, processed tires, asbestos, carpet, cardboard, paper, glass, plastic, furniture other than appliances, or other materials approved by the Department, that are not expected to produce leachate that poses a threat to public health or the environment.

Unit pricing is for hauling off (including disposal fees of the waste to an appropriate landfill).

Q2.7 Exhibit A - <u>Drawing C05</u>; PICKLEBALL CTS - The pickleball courts show only a 20-ft dimension for the width of the striping area. Please list all the dimensions needed to build the pickleball courts.

Each court is striped at 20' x 44', each paved area is 32' x 64'.

Q2.8 Exhibit A - <u>Drawing C05</u>; PICKLEBALL CTS - Please specify the playing surface and substrate of the pickleball courts.

The typical section for the pickleball court surface shall be:

- 12" of stabilized subbase with a minimum LBR of 40
- 6" of graded aggregate base compacted to 98% of maximum density modified proctor per ASTM D1557
- 2" binder course of hot mix asphalt, SP 12.5.
- 1.5" of hot mix asphalt, SP-9.5
- Acrylic color playing surface

A court specification has been included with this response for bidder information and use. SEE EXHIBIT B1.

Q2.11 Exhibit A - <u>Drawing C05</u>; BASKETBALL CTS - Please specify the playing surface of the basketball courts.

The typical section for the basketball court surface shall be:

- 12" of stabilized subbase with a minimum LBR of 40
- 6" of graded aggregate base compacted to 98% of maximum density modified proctor per ASTM D1557
- 2" binder course of hot mix asphalt, SP 12.5.
- 1.5" of hot mix asphalt, SP-9.5
- Acrylic color playing surface

A court specification has been included with this response for bidder information and use. SEE EXHIBIT B1.

- Q2.13 Exhibit A Drawing C05; BOARDWALK what restrictions do we need to abide by when performing the boardwalk work in the wetland impact area?

 Work should be accomplished in the boardwalk impact area. No materials or equipment should be stored within the wetland areas.
- Q2.14 Exhibit A <u>Drawing C12</u>; BOARDWALK GUARD RAIL what is the material that is called out as 1" at the guardrails for the boardwalk?

 The 1" dimension is the exposure of the 2x6 and 2x8 rails. Th rails are to be inset into the 6x6 post ½".
- Q2.15 Exhibit A <u>Drawing C05</u>; SITE LIGHTING Bid Documents do not appear to indicate Site Electrical: distribution layout, power requirements and/or transformer locations for the Site Lighting as shown on Exhibit C5 AE Plans 21168A Lighting 2024 04-26. Please advise how Site Electrical costs are to be included with the unit price for this item. Did not see it on the price sheet either.

 After review, this was left out of the design. **Please quote the lighting package only**. The City will get with the design team to develop a lighting electrical plan that will include panel, backboard, conduit, etc. and process it as a change order after contract selection.
- Q2.16 Exhibit A <u>Drawing C08</u>; WALL lists only the top of wall elevation for the segmental retaining wall. Please give either the bottom of wall elevation, or the total area of retaining wall.

 There is approximately 4,010 square feet of exposed retaining wall face area.

Please find the attached drawings with markups to better explain the vendor's request.

- Q2.20 Exhibit A Drawing C04 & C05 FENCING: Will you provide a spec sheet for the fencing scope of this project, (I.E) height, chain finish, post depth, bonding points if required? See attached specification for fencing details. SEE EXHIBIT B1
- Q2.21 Exhibit A Drawing C04 & C05; FENCING Will you provide a site plan for the fencing. The markups I've made on the attached document is my assumed position of the fencing but I do not see a key on any of the civil drawings that specifically calls the fencing out? Fence and gate locations are depicted on site plans. Site plan will be updated with legend to show fence line type.
- Q2.22 Exhibit A Drawing C04 & C05; FENCING Will you provide the size and finish of all the fence gates on this project and if necessary, will you update the pricing sheet to reflect the totals for each size of gate that is required?

 There are a total of 5 pedestrian gates along the exterior fenced area. Each gate shall be 4 feet in width. There area a total of 20 pedestrian gates at the pickleball courts. Each gate shall be 4 feet in width. There are two double gates for vehicular access. Each gate shall be 26 feet in width total.
- Q2.23 Exhibit A Drawing C04 & C05; FENCING On the pricing sheet the fencing is called out as 1,927 Linear Feet of Black vinyl coated chain link fencing. The specs on Exhibit A Sheet 16 call for the fencing to be hot dipped galvanized and doesn't mention the black vinyl coating.

Fencing shall be black vinyl coated.

- Q2.24 LANDSCAPING Will the irrigation system use City water or another source? Irrigation is proposed to be served by a new well.
- Q2.25 IRRIGATION Bid Documents do not appear to indicate Plans and Specifications or source (Reclaimed/ Potable/Well). Please advise how Irrigation costs are to be provided with the unit price for this item.

Irrigation costs are listed as a total lump sum item. An appropriate irrigation design should be supplied by the contractor (via a specialized irrigation subcontractor or other identifying well size, required piping, and water requirements).

- Q2.26 LANDSCAPING Will the drainage areas require Bermuda sod? Yes, all landscape areas shall be sodded with **TifTuf Bermuda**.
- Q2.27 LANDSCAPING Is Bermuda sod meant to be installed on soccer fields as well? If so, are there any other special grading or irrigation requirements on those four soccer fields? Yes, soccer fields are to be sodded **TifTuf Bermuda** or turf, as provided in the alternate bid item. Grading shall be complete as shown on Sheets C07 and C08 of plan set.
- Q2.28 LANDSCAPING Is there any landscaping involved with the playground? Playground area is to be coordinated with the City of Fort Walton Beach.
- Q2.34 Will the City consider extending the bid opening another week? YES. Please see Item 1.2 above.
- Q2.44 RE: field surfacing:
 - Is it the City's wish to have a per field price or a total price for all?
 - Does this price need to include the aggregate base work as specified by turf manufacturers?

- Q2.29 DOORS Hardware spec states there is a door hardware schedule, and the door schedule on sheet A5.1 says door hardware will be selected by the Owner. For bidding purposes, we need either a door hardware schedule, or a hardware allowance. Please advise.
- Q2.30 DOORS The door schedule A5.1 lists hollow metal frames and wood frames, and the door details appear to show pre-hung wood doors. However, the specifications call for hollow metal frames. Please clarify which is correct.

- Q2.31 DOORS It states in hollow metal spec, interior doors 1-3/8" thick 20ga. HM doors are typically 1-3/4" --- is this correct?
- Q2.32 DOORS Is exterior door model 1, 20ga? It should be16ga, hurricane-rated doors. Please confirm.

Q2.33 DOORS - Are all frames to be knockdown, interior & exterior?

- Q2.36 Sheet E0.1 Fire Alarm Gen. Note G states; Upon completion the campus wide fire alarm system shall be recertified. The two separate structures are over 700' apart. Is this telling us to connect the two systems so that both systems work in unison, (One system alerts, both systems alert)?
 - This will require a bunch of work, (750' trench with conduit & wire). Also, if this is the intent, we would highly recommend a fiber optic connection from FA panel to FA panel, do to lightning strikes, (NOT COPPER)!!
